Exhibition Area, Participation Fee and Basic Conditions for Participation:

The Organisers offer built-up furnished booths in various sizes containing basic furniture and furnishings as below:

The Organisers also offer Indoor Raw space (minimum area to be booked is 30 sq.m.) and Outdoor Raw Space (minimum area 100 sq.m.).

The prospective Exhibitors may apply on the application for participation form (space application form) along with payment. Allotment will be on first-come-first served basis subject to receipt of payment. All payments should be made by Demand Draft payable to Federation of Indian Chambers of Commerce & Industry, payable at New Delhi, India. Application for space for both raw & built-up booths may be made in combinations / multiples of contiguous plots / booths. For a combination of contiguous, furnished indoor standard booths allotted, provision of partitions within the area would be optional.

Exhibitors shall be entitled for free passes for Exhibitors' Staff manning the stands as per the entitlement during the Fair and one free entry in the Exhibitor Directory.

Wherever indoor raw space is allotted, the Exhibitors will have to erect their stand on their own, in line with the Rules and Guidelines for Design & Construction of Stand.

'Application for participation' must be submitted with complete payment.

The Organisers reserve the right to reallocate space, change the layout, add or delete corridors in the Space Plans, which may affect the orientation of some Exhibitors. The decision of the Organisers shall be final and binding to all.

The Organisers reserve the right to turn down applications for participation or even deny participation to Exhibitors already confirmed.

Mode of Payment

All payments within India to be made by Demand Draft, favouring "Federation of Indian Chambers of Commerce and Industry", payable at New Delhi, India, in Indian Rupees.

Contract: Exhibitor enters into a contract with the Organisers upon submission of this document. The proposed Exhibitor agrees to participate in India Stonemart 2021 and to abide by the regulations and by-laws. Any breach of contract by the proposed Exhibitor makes the Exhibitor liable to pay the space rental in full to the Organisers.

GST: Government of India has levied GST on all exhibition services. The GST is payable on the stall rentals, electrical charges, advertisement charges and other fair services for the exhibition, to be paid by all exhibitors. The GST payable on the captioned fair will be 18% on the billing amount; which shall be payable over and above the rates for rentals, advertisement and other services. Please note that FICCI's GST No. is 07AAACF1282E1Z1. GST is not applicable on refundable security deposit.

Electricity: Available at 230 V Single Phase and 400V three Phase, A.C. 50 Cycles. While general lighting in the hall and the booth is free of cost, Exhibitors would be required to pay electricity consumption charges for additional connected load for demonstration of machinery and equipment at the rate specified in the exhibitor manual. The Exhibitors booking Indoor Raw Space and Outdoor Raw Space will have to give their exact requirement of connected load in KW, in advance by 2<sup>nd</sup> August 2021.

The Organisers will provide electricity at a suitable point in the stand. Internal distribution to the machinery / equipment will have to be arranged by the Exhibitor's electrical contractor at their own cost, keeping in mind the electricity system norms.

Free Entry in the Exhibitors' Directory: Every Exhibitor is entitled to a free entry in the Exhibition Directory, based on the information provided by the Exhibitor as per Exhibitor Information Form. This form will have to be submitted before 2<sup>nd</sup> August 2021. Forms received after 2<sup>nd</sup> August 2021 may not be included in the Exhibitors' Directory.

Approval of Design of Stand: Every Indoor Raw Space and Outdoor Raw Space Exhibitor will have to submit the stand design and scale mock-up, complete with details of Exhibit, Electricity and other installation and Elevation details in four copies for approval of the Organisers before 31<sup>st</sup> August 2021.

Sale of Exhibits: Sales are not allowed during the Fair. However, negotiations for sale may be conducted. Removal of any Exhibit during the fair-period is strictly prohibited.

Customs and Import Clearance Services: Customs, Clearing & Forwarding services would be available at the Fair Grounds at extra cost. JECC/Organiser would appoint clearing and forwarding agents who will assist in the handling and completing Customs formalities, if required. The Exhibitor would be required to contact them directly for such assistance. Movement of Exhibits in the Fair Grounds by agencies other than official clearing and forwarding agents is prohibited.

Possession of Space: For Exhibitors taking built-up space, Exhibits for display should be brought to the Fair Grounds on 21<sup>st</sup> November 2021. Exhibitors taking outdoor space should take possession on 20<sup>th</sup> November 2021. No entry of goods will be allowed after 1600 hrs on 24<sup>th</sup> November 2021.

Stand Completion: All materials to be installed by 24<sup>th</sup> November 2021.

Removal of Exhibits: All materials to be removed by 1800 hrs on 29<sup>th</sup> November 2021.

Damages to Fair Ground: Exhibitors will be required to make good all damages or make payment for the damages incurred to the Fair Ground facilities / buildings etc. during setting up and / or Fair period and / or dismantling period.

Payment Schedule: Stalls shall be booked on payment of stall rental, subject to the following schedule:

- Minimum 25% of the total space rental at the time of booking.
- Minimum 50% of the total space rental by 31<sup>st</sup> March 2021.
- Full payment of total space rental by 2<sup>nd</sup> July 2021.

Exhibitors are required to adhere to the payment schedule as above, failing which the booking shall be deemed to be cancelled and organisers shall be authorised to revoke the booking. In such a case, any amount paid by the Exhibitor shall be forfeited, subject to the conditions of the cancellation rules below.

Cancellations: If the Exhibitor withdraws from this contract, said payment will be refunded at the following rates:

For existing confirmed companies

- Till 30<sup>th</sup> November 2020 - 50% of the total stall rental paid.
- After 30<sup>th</sup> November 2020 - No refunds will be given on cancellation.

For New bookings

- Till 15<sup>th</sup> April 2021 - 50% of the space rental paid.
- Till 31<sup>st</sup> May 2021 - 25% of the space rental paid.
- After 31<sup>st</sup> May 2021 - No refunds will be given on cancellation.

- Stall Cancellation refund is subject to 100% payment of Stall Rental.
- No refund will be given on the partial payments made.

Refund Rules & Regulations: Any excess payment made by the exhibitors towards stall rental / sponsorships/electricity shall be processed only after the reconciliation of entire exhibition accounts which is a time consuming process. Exhibitors have to bear with us for the same. Organisers shall try to refund the security deposits within a period of one month after the event closure but in case of any delay in the process exhibitors are requested to keep patience. Exhibitors are requested to deduct the TDS on the payment made towards stall rental / sponsorships timely. The organisers shall not be responsible or held liable at any point of time for any delay in TDS deduction by the exhibitor.

Insurance: Against all ascertainable risks from transportation to display and removal should be done by the Exhibitors at their cost. Organisers will in no way be responsible.

Photography: The Organisers retain the right to photograph any exhibit for their use.

Settlement of Dues: Any and all expenses chargeable to the Exhibitors must be settled before the closure of the Fair to ensure smooth removal of goods from the fair site.

Force Majeure: If the Exhibition is abandoned, cancelled or suspended in whole or in part by reasons of war, national emergency, labour dispute, non-availability of Exhibition premises or any other cause not within the control of the Organisers, the Organisers may, at their own discretion, repay the rental paid by the Exhibitor in full or part thereof. But they shall be under no obligation to repay full or part thereof such rental and shall be under no liability in respect of any action, claims or losses.

Dispute Resolution and Governing Law: All unresolved matters, questions, disputes or differences whatsoever arising between the Exhibitor and Organisers shall be settled by arbitration in accordance with the rules of the Arbitration and Conciliation Act 1996. The arbitration proceedings shall be conducted in English language in Jaipur, India. The arbitration agreement contained in this paragraph shall be solely and exclusively governed.
