LIFETIME ACHIEVEMENT AWARD

About the Award

CDOS Lifetime Achievement Award for the stone industry is instituted to honour and bestow recognition to individual(s) who made outstanding contributions over his/ their lifetime for sustainable development of dimensional stone industry in India.

In addition, individual(s) who have demonstrated outstanding mentorship to upcoming entrepreneurs in the field or provided noteworthy service to the community will also be considered for the award.

The award will be presented biennially during the opening ceremony of India Stonemart International Stone Industry Exhibition.

The award includes:

- A Citation
- Recognition during opening ceremony of India Stonemart
- Hosting details of the winner alongwith Photograph and achievements in the 'Lifetime Achievement Award Webpage' of CDOS website.

Eligibility Criteria

The Lifetime Achievement Award is intended for individual(s) who have had a significant impact on a large number of individuals / organizations / community as a whole.

The individual should have contributed substantial time and expertise to help sustainable development of dimensional stone industry in the area of mining/ processing/ introduction of newer technology, tool, machinery / stone waste utilization/

environmental protection / energy saving technology / development of innovative product / training / important publications etc.

Since it is a Lifetime Achievement Award, the recipient should have a minimum experience/ involvement of 25 years in dimensional stone industry.

Nomination Procedure

After notification of the Award for a particular 2 year period by CDOS, any individual / association / organization / firm etc. can nominate an individual as per the eligibility criteria in prescribed format alongwith passport size photograph and bio-data of the person so nominated with a consent letter of the nominated individual.

Selection Process

Once the nomination period is closed, a Jury of eminent personalities in the stone industry will scrutinize the nominations and decide the winner (s) as per prescribed eligibility criteria.

Last date for submission of Entries

Last date for submission of entries in prescribed form is 15th September 2022 and award giving ceremony is proposed to be organized during 11th edition of India Stonemart exhibition which is scheduled during November 10-13, 2022 at JECC, Jaipur

Entry form duly filled-in, along with all details, should be sent by Registered post/ courier to CDOS at the address as mentioned below, so as to reach not later than 15.09.2022.
